What is the overall <a href="#">deductible</a> ?	In-Network: \$2,000 individual/ \$4,000 family; Out-of-Network: \$0	Generally, you must pay all the costs from <a href="#">provider</a> up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family member on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meet the overall family <a href="#">deductible</a> .
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes, all In-Network preventive care services.
