<b>What is the overall deductible?</b>	Network: \$1,250 Individual / \$2,500 Family Per policy year. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.
<b>Are there services covered before you meet your deductible?</b>	Yes. Preventive care and categories with a copay are covered before you meet your deductible.
