<b>What is the overall deductible?</b>	Designated <u>Network</u> and <u>Network</u> : \$1,000 Individual / \$2,000 Family Per policy year. <b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive care</u> is covered before you meet your <u>deductible</u> .
